Valley News Live – Luther Family Ford Weather Kid 2020-2021 OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. PROMOTION DATES

- a. The Luther Family Ford Weather Kid ("Promotion") will begin on 5:00am CT Monday, September 14, 2020 and end on 5:00PM CT Thursday, April 26, 2021. The start date is the date we first speak about the contest on-air. The end date of the promotion is the date/time the station notifies winner(s), not the entry deadline.]
- b. The deadline for entries is 5:00PM CT Monday, April 20, 2021 to allow for production time and be sure this date/time does not conflict with the date/time the last winner is selected. (5b)

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to parents or legal guardians of children ages 8 -18 at the time of entry and who live in one of the following counties in the state of North Dakota: Towner, Cavalier, Pembina, Benson, Ramsey, Walsh, Nelson, Grand Forks, Eddy, Griggs, Steele, Traill, Stutsman, Barnes, Cass, LaMoure, Ranson, Richland, Dickey, or Sargent. Also the following counties in the state of Minnesota: Kittson, Roseau, Lake of the Woods, Marshall, Polk, Pennington, Red lake, Clear Water, Norman, Mahnomen, Clay, Becker, Wilkin, or OtterTail (the "Broadcast Viewing Area"). Employees of KVLY or KXJB (the "Station"), its parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners, other broadcasting stations in the Broadcast Viewing Area, and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations. Void outside the United States, in NY and FL, as applicable, and where prohibited.
- b. An individual may win this contest only one time. Winners may be invited back for additional on-air appearances.
- c. In order to claim the prize, the parent or guardian of a winning child must be present during their on-air appearance at Valley News Live.
- d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify

any entry from any individual who does not meet the eligibility requirements, and will also delete any entry as required by law.

3. ENTRY

- a. To participate in the Promotion, you must enter by the following method: Parents/guardians must complete and turn in a registration form at the participating Luther Family Ford location, 3302 36th St. South, Fargo, ND 58104 or online by visiting www.valleynewslive.com and clicking on the "contest" tab. All requested information on the registration form or online entry form, as applicable, including parent/guardian contact information, must be filled out. Entries submitted will not be acknowledged or returned. Use of any device to automate online entry is prohibited. Proof of online entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's computer is the official time-keeping device for the Promotion.
- b. Parents/guardians may enter each of their children as many times as they like. Parents/guardians must fill out a separate entry form for each child.

4. PRIZES AND ODDS OF WINNING

- a. The sponsors each week will randomly draw a winner from all entries. There will be a total of thirty (30) weather kids drawn during the promotion. Each Weather Kid winner receives: the opportunity to appear on-air in the weather segment of a 5:00pm Valley News Live program with a Valley News Live onair personality, a weather station, and Luther sweatshirt-and a Valley News Live t-shirt. Estimated total value of each prize is one hundred and sixty (\$160) dollars.
- b. ODDS OF WINNING DEPEND UPON THE NUMBER OF ENTRIES RECEIVED.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, at its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.
- WINNER SELECTION AND NOTIFICATION
- a. Decisions of Station management with respect to the Promotion are final.
- b. Winners will be randomly drawn two to three (2-3) weeks prior to on-air appearance. There will not be a weather kid appearance Thursday, November 26, 2020; Thursday, December 24, 2020; or Thursday, December 31, 2020. Valley News Live reserves the right to cancel a weather kid appearance for any reason without notice.

- c. Parent/guardians of the winner must execute and return any required affidavit of eligibility and release, publicity release, and/or guest/traveling companion release prior to their child's scheduled on-air appearance on Valley News Live or winner will be disqualified and the prize will be forfeited and an alternate winner(s) may be chosen by random drawing. If a potential winner(s) cannot be contacted, fails to complete, sign and return any required affidavit of eligibility and release, publicity release, and/or guest/traveling companion release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner(s) will be disqualified and will forfeit the prize. 6. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the parent/guardian of the winner(s). Parent/guardian will be required to complete and submit an IRS Form W-9 or the equivalent including a winner's full Social Security Number for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station (in combination with any prizes won in Promotions run by any other Gray television station) in a calendar year with an aggregate value of \$600 or more. - ii. acknowledge that the Station reserves the right, in its sole discretion, not to use the Materials at all: and
- iii. represent and warrant that: you are the parent/guardian of any minor featured in the Materials; you have the full legal right, power and authority to grant to the Station the license provided for herein; you own or control the complete exhibition and other rights to the Materials you submitted for the purposes contemplated in this license; and neither the Materials nor the exercise of the rights granted herein shall infringe upon or violate the right of privacy or right of publicity of, or constitute a libel or slander against, or violate any common law or any other right of, any person or entity; and
- d. Prior to awarding any prize or prize certificate, and depending on the nature of the prize and eligibility requirements of the Promotion, the Station in its sole discretion may require verification of Promotion winner's or winners' identification by a showing of valid government-issued photo identification. **IF THE WINNING CHILD DOES NOT HAVE A VALID GOVERNMENT-ISSUED PHOTO IDENTIFICATION OR DRIVER'S LICENSE, A BIRTH CERTIFICATE ISSUED BY THE COUNTRY OR STATE OF THE CHILD'S BIRTH, MAY BE USED.** A "commemorative birth certificate," sometimes given by hospitals (with footprints and fingerprints), is NOT an acceptable or legal form of identification.
- e. The Station further reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the Promotion, or any part of it, if it is not capable of completion as planned or if any fraud, technical failures or any factor beyond the Station's control, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Promotion as determined by the Station in is sole discretion. Any attempt by an entrant or any person to deliberately damage any station website, Facebook Page, and/or any other social networking site used in the Promotion or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws. Should such an attempt be made, the Station reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The Station's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to modify, terminate, suspend or cancel the Promotion and shall not be required to award a substitute prize.

- g. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion, or in the announcement of a prize; (ii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, malfunctions, disconnections, other technological failures, telephone service outages, delays, dropped calls, or busy signals, or any other difficulties that may prevent an individual from sending or receiving a text message; or (iii) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, incorrect, or late entries. - vi. if for any reason a claim or dispute regarding the Promotion or these Official Rules proceeds in court rather than through arbitration, there will not be a jury trial.
- i. The invalidity or unenforceability of any provision of these Official Rules, including but not limited to the agreement to arbitrate, shall not affect the validity or enforceability of any other provision. If any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained herein.
